The Totalization Treaty between the U.S. and Mexico was negotiated and ratified by both nations' Social Security agencies during the Bush Administration.

Thanks to the pressure U.S. Border Control and thousands of Americans put on President Bush to reject this treaty, this agreement was never signed before he left office.

But the treaty still exists. And pro-illegal alien groups like La Raza, ACORN, and MALDEF are now demanding President Obama sign this treaty!

If that happens — if this Administration decides to move forward the Bush Administration's plan to funnel hundreds of millions of dollars out of the Social Security Trust Funds and into the pockets of millions of Mexican illegal aliens — **it will bankrupt our Social Security system!**

That's why U.S. Border Control is leading this important battle in Washington to protect your Social Security benefits against those who are eager to turn over your hard-earned benefits to millions of illegal aliens. **But we need your voice as a concerned American in this debate TODAY!**

U.S. Border Control helped expose the details of this treaty with Mexico when information about it was first leaked five years ago.

*And now I need your help to ensure this dangerous agreement is not resurrected by the Obama Administration.*

What's most alarming is, unlike most treaties, this Social Security Treaty with Mexico does not need to be passed by Congress! Should the President sign it, Congress will have just 60 days to reject it.
